Religious Prisoners in Vietnam

	1. The Most Venerable Thich Quang Do: b.1928. Residence: He is under "temple" arrest at the Thanh Minh Zen Center, 90 Tran Huy Lieu St., Phu Nhuan District, Ho Chi Minh City. He is a long-time member (currently Patriarch) of the Unified Buddhist Church of Vietnam (UBCV). In his various capacities within the UBCV leadership, he has steadfastly refused to join the government-created Buddhist Church. He has been alternatively imprisoned, internally exiled, or under house arrest since 1977. He was awarded the Thorolf Rafto Memorial Prize and other prestigious human rights prizes.
	2. Mr. Bui Van Trung: b. 1964. Residence: 277 Phuoc Hoa Village - Phuoc Hung Commune - An Phu District - An Giang Province, is the father of another detainee, Mr. Bui Van Tham. Both are Hoa Hao Buddhists. His sentence is 4 years in prison pursuant to Article 257 of the penal code, hampering government officials who were carrying out their asssignments. Arrested on 10/30/2012, he was interned in Prison Z30A, Section 2, in Xuan Loc District, Dong Nai Province. He was released in 2016.
wind of a grant of the property of the propert	3. Mr. Dang Xuan Dieu: b. 1977. Residence: Nhan Hoa Sub-Parish, Vinh Diocese. A Catholic, his religious activities resulted in his arrest and the sentence is 13 years in prison and 5 years of probation pursuant to Article 79 of the penal code, plotting to overthrow the government. Arrested on 07/30/2011, he is currently in Nghi Son Prison in Thanh Hoa Province. He suffers from low blood pressure and other ailments. The government has prevented his family from visiting him and supplying him with minimal necessities.
	4. Mr. Ho Duc Hoa: b. 1974. Residence: Yen Hoa, Quynh Vinh Commune, Quynh Luu District, Nghe An. He is a Catholic from Vinh Diocese who advocates for religious freedom. His sentence is 13 years in prison and 5 years of probation pursuant to Article 79 of the penal code, plotting to overthrow the government. Arrested on 7/30/2011, he is currently in Nam Ha Prison in Ha Nam Province.
The same of the sa	5. Mr. Nguyen Cong Chinh: b. 1966. Residence: Vinh Quang, Kon Tum Town. An evangelical pastor serving Montagnard Christians, he was arrested on 4/28/2011. His sentence is 11 years pursuant to Article 87, undermining national solidarity. He is currently in An Phuoc Prison in Phu Giao District, Binh Duong Province. They gave him frequent beatings in prison because he denied that he had committed any crime. The government has been making life very difficult for his family. He is in poor health.

6. Mr. Pham Ba Thong: b. 1962. Residence: Village 2, Phu Le Commune, Ba Tri District, Ben Tre Province. A Mennonite, he was arrested on 7/18/2010. His sentence is 7 years in prison and 5 years of probation pursuant to Article 79 of the penal code, plotting to overthrow the government. He is currently in Prison Z30A, Section No. 2, in Xuan Loc District, Dong Nai Province.
7. Mr. Phan Ngoc Tuan: b. 1953. Residence: Phan Rang-Thap Cham, Ninh Thuan. A Lutheran, he advocates for the return of land that the government had illegally confiscated. Arrested on 08/10/2011, he was sentenced to 5 years in prison and 3 years of probation pursuant to Article 88 of the penal code, spreading propaganda against the socialist government of Vietnam. He is currently in Prison T345 in Xuyen Moc District, Ba Ria – Vung Tau Province. The government has been causing major difficulties to his family's livelihood. The impoverished family has difficulty visiting him and bringing him minimal essentials.
8. Ms. Duong Thi Tron: b. 1947. She is a Hoa Hao Buddhist who advocates for religious freedom. Her sentence is 9 years in prison pursuant to Article 245 of the penal code, disrupting public order. Arrested on 10/02/2006, she was detained in Prison Z30A in Xuan Loc District, Dong Nai Province. She suffers from low blood pressure and other ailments. Her impoverished family has difficulties supplying her with minimal necessities in prison. She was released in 2016.
9. Rev. Nguyen Van Lý: b.0 5/15/1946, in Ba Binh Village, Vinh Chap, Vinh Linh, Quang Tri Province. A Catholic priest in Hue Archdiocese, he formed Block 8406 (in 2006) and led many protests to demand religious freedom and the return of confiscated Church property. Arrested in 2007, his sentence is 8 years in prison pursuant to Article 88 of the penal code, spreading propaganda against the socialist government of Vietnam. He was last in Nam Ha Prison in Ha Nam Province. His health is poor. He was released in 2016.
10. Mr. Nguyen Van Minh: He is an independent Hoa Hao Buddhist who campaigned for freedom of religion and conscience. He was arrested on February 11, 2014 on charges of "causing public disorder" as he was travelling to visit former prisoner of conscience Nguyen Bac Truyen and his wife. On 08/26/2014, the Dong Thap Provincial People's Court sentenced him to 2.5 years in prison. He is detained in Dong Thap Province. Both his father-in-law Bui Van Trung and brother-in-law Bui Van Tham had been imprisoned for defending religious freedom. He was released in 2016.
11. Venerable Thach Thuol: b. 1985. Residence: Vinh Hai Commune, Vinh Chau Town, Soc Trang Province. As the head monk of Ta Set Pagoda, he often spoke out against the government's mistreatement of Khmer Krom Buddhists who refused to be absorbed into the government-created Vietnam Buddhist Sangha. Venerable Thach Thuol also

criticized the government for rejecting his multiple requests that his temple be allowed to teach Khmer language to Khmer Krom children. At the order of the government, the Patriotic Monks Association decided to defrock him. As the representative of this association, escorted by the police, came to evict him from his own temple, his followers put up resistance. As he and three other Khmer Krom Buddhists attempted to flee to a safe location, they were arrested on 05/20/2013. On 09/27/2013, he was sentenced to six years of imprisonment on the charge of "fleeing abroad to act against the people's government".
 12. Venerable Lieu Ny: b. 1985. Residence: Vinh Hai Commune, Vinh Chau Town, Soc Trang Province. As the deputy head monk of Ta Set Pagoda, he supported Venerable Thach Thuol in advocating for religious freedom for Khmer Krom Buddhists. At the order of the government, the Patriotic Monks Association ordered him to be defrocked and evicted from his temple. As he and three other Khmer Krom attempted to flee to safety, they were arrested on 05/20/2013. On 09/27/2013, he was sentenced to four years of imprisonment on the charge of "fleeing abroad to act against the people's government". 13. Thach Phum Rit: b. 1989. Residence: Vinh Hai Commune, Vinh Chau Town, Soc Trang Province. A Khmer Krom Buddhist, he supported Venerables Thach Thuol and Lieu Ny in defending the religious and cultural rights of Khmer Krom Buddhists. He was arrested on 05/20/2013. On 09/27/2013, he was sentenced to three years of imprisonment on the charge of "fleeing abroad to act against the people's government". He was released in 2016.
 14. Mr. A Byo: b. 1967. Residence: Bon Ol Btung Hamlet, Quang Tin Commune, Dak R'lap District, Dak Nong Province. An evangelical pastor who had defended his community's freedom of assembly and freedom of religion over several years, he was arrested on 12/10/2012. After detaining him without a trial until 08/13/2014, they tried him and sentenced him to 4 years in prison pursuant to Article 87. He is currently in Gia Trung Prison, Gia Lai Province. 15. Mr. A Chi: b. 1964. Residence: Kret Krot Hamlet, H'ra
Commune, Mang Yang District, Gia Lai Province. A Chi is a Protestant deacon and lead of the Youth Ministry. The local government prevented him from performing his duties, citing the reason that preaching is forbidden at his village. He protested and refused to comply. As a result, he was summoned to the local police office several times and ultimately was sentenced to 8 years in prison. He was arrested on 10/18/2009 and is currently serving his sentence in An Phuoc Prison in Binh Duong Province. 16. Mr. A Dân (aka Apunh), preacher of the Southern Baptist Church in Kontum on March 11, 2015 led 11 church members

from Kontum Province to a religious training program in Ho Chi Minh City. They just reached nearby Daklak Province when Daklak police stopped them, searched and confiscated their cash and Bibles. Police brought them back to Kontum Province and delivered them to police in that province. A Dân refused to sign a forced confession that they were trying to leave the country illegally. The other victims signed under pressure. Police released the others while detaining A Dân. The Kontum People's Court sentenced him to 24 months of imprisonment under the trumped up charge.
17. Mr. A Dao: b. 1981. Residence: Gia Xieng Village, Ro Koi Commune, Sa Thay District, Kontum Province. A pastor of the Montagnard Evangelical Church of Christ, he advocated for religious freedom for his fellow church members in the Central Highlands and elsewhere. In August 2016 he attended a recent conference on Freedom of Religion in SE Asia and the ASEAN Civil Society Conference and ASEAN People's Forum. On 04/28/2017 he was sentenced to 5 years in prison for "helping individuals to escape abroad illegally", a charge he denied. He is detained at Gia Trung Detention Cetner, Gia Lai Province.
18. Mr. A Gyun: b. 1980. Residence: Kret Krot Hamlet, Hra Commune, Mang Yang District, Gia Lai Province. A devout Christian, he engaged in religious activities and participated in a demonstration to protest government suppression that led to a "mobile" court (installed in his village) sentencing him to 5 years in prison on 04/26/2016 pursuant to Article 87, undermining national unity. Four other Montagnard Christians were also arrested and sentenced to long prison terms.
19. Mr. A Quyn: b. 1973. Residence: Ha-mong Katu Hamlet, Hamong Commune, Dak Ha District, Kontum Province. He practiced his evangelical faith without government aproval. He has been arrested and brought to the local police station for interrogation. The local authorities disrupted group worship sessions involving church members, prohibited future group worships, harassed his family, and brutally tortured him. Arrested on 11-18-2013, he was sentenced to 9 years and 6 months in prison pursuant to Article 87. He is currently in Nam Ha Prison in Ha Nam Province.
20. Mr. A Tach (Ba Hloi): b. 1959. Residence: Kon Hram Hamlet, Dak Tre Commune, Kon Ray District, Kontum Province. A Catholic preacher, he and many Christians in his village (where he was preaching) protested against the local government for its intervention in the Church's affairs. Fearing this would get out of control, the local government arrested Mr. A Tach on 10/11/2012 and sentenced him to 11 years in prison, followed by 3 years of probation. He is currently detained at Team 23, Sub Division 1 of Prison #5, Thanh Hoa Province.

21. Mr. A Tík: b. 1952. Residence: Kon H'ram Hamlet, Dak To're Commune, Kon Ray District, Kontum Province. He was arrested and then on 04/26/2016 sentenced to 8 years in prison and 3 years of hous arrest in a case involving 4 other Montagnard Christians. He was accused of undermining national unity under Article 87.
22. Mr. A Yum (Balk): b. 1940. Residence: Hamlet 5, Dac Tre Commune, Kon Ray District, Kontum Province. As a member of the Ba Na ethnic minority group, he had been advocating for religious freedom in the face of government suppression. As a result, he was arrested on 01/06/2012 and sentenced to 8 years in prison pursuant to Article 87.
23. Mr. Amlinh: b. 1943. Residence: Tuoh Klah Hamlet, Glar Commune, Dak Doa District, Gia Lai Province. He joined other Christians in protesting against the local government's suppression of religious freedom. He was arrested in 2008, sentenced to 8 years in prison, followed by a 3-year probationary period, and detained in Prison #5, Town of Thong Nhat, Yen Dinh District, Thanh Hoa Province. As a result of being tortured in prison, he suffers from several ailments. Although he has returned home, the probation from traveling outside of his immediate community has prevented him from seeking medical treatment outside of his
community. He was released from prison in March 2016. 24. Mr. Buyk: b. 1952. Residence: Kret Krot Hamlet, Hra Commune, Mang Yang District, Gia Lai Province. As an evangelist of the Kret Krot Evangelical Church, he had been defending his Church's right to freedom of religion. He was
requested to go to the local police station for interrogation. There, his interrogators beat him and issued an order forbidding him to engage in religious activities. Arrested on 02/03/2013, he was sentenced to 8 years in prison and incarcerated in Xuan Phuoc Prison, Phu Yen Province.
25. Mr. Dieu Bre: b. 1969. Residence: Quang Tin Hamlet, Dak R'lap District, Dak Nong Province. An evangelist of an evangelical church not recognized by the government, he was arrested on 08/14/2013 and sentenced to 4 years and 6 months in prison for his religious activities. He is currently detained in Xuan Phuoc Prison, Dong Xuan District, Phu Yen Province.
26. Mr. Dieu Dong: b. 1966. Residence: Bon Blutung Hamlet, Quang Tin Commune, Dak R'lap District, Dak Nong Province. He is a pastor who belongs to an evangelical Church that is not recognized by the local government. Pastor Dieu Dong and his evengelists had been harassed by the local government and police forces that aimed to prevent them from worshiping. He was arrested on 10-12-2013 when he and the Church rotested against the local government to demand religious freedom. He was sentenced to 4 years in prison and 3 years of probation. He is currently serving his

sentence in Xuan Phuoc Prison, Dong Xuan District, Phu Yen Province.
27. Mr. Dieu X-Ri: b. 1962. Residence: Dak Ngo Hamlet, Tuy Duc District, Dak Nong Province. A deacon of an evangelical
church not recognized by the government, he was sentenced to 2 years in prison and 3 years of probation for his religious activities. He is currently detained in Xuan Phuoc Prison, Dong Xuan District, Phu Yen Province.
28. Mr. Dinh Ngo: b. 1987. Residence: Kung Kon Hamlet, An Thanh Commune, Dak Po District, Gia Lai Province. An evangelical pastor since 2011, he joined other members of his ethnic group in a demonstration in Dak Po District to protest against the local government's suppression of religious freedom. Arrested on 04/26/2013, he was sentenced to 7 years and 6 months in prison, and incarcerated in Section #2 of An Phuoc Prison, Binh Duong Province.
29. Mr. Dinh Ku: b. 1972. Residence: Kuk Kon Hamlet, An Thanh Commune, Dak Po District, Gia Lai Province. A devout Catholic, he stood up and protested against the Gia Lai authorities' policy of suppressing religious freedom. As a result, he was arrested on 04/26/2016 and sentenced to 7 years in prison pursuant to Article 87, undermining national unity, in a case involving 4 other Montagnard Christians. He is currently detained in Prison #5, Yen Dinh District, Thanh Hoa Province.
30. Mr. Kpa Binh: b. 1976. Residence: Plei Pang Hamlet, Ea Glai Commune, Chu Se District, Gia Lai Province. An evangelical pastor, he was arrested in 2009 for participating in a demonstration demanding religious freedom because the government had been preventing him from carrying out his pastoral duties. He was sentenced to 9 years in prison pursuant to Article 87.
31. Mr. Kpa Sinh, b. 1959 of JRai ethnicity. For demanding religious freedom he was sentenced on April 5, 2011 to 8 years in prison and 3 years of house arrest for "undermining the national unity policy" (article 87 of the Penal Code). He is currently detained in Gia Lai Province.
32. Mr. Ksor Y Dú, born 1963; Ethnicity Ede; sentenced on 15/11/2010 to 6 years in prison and 3 years of house arrest for "undermining the unity policy" (article 87 of the Penal Code); detained in Phu Yên.
33. Mr. Nhi ((Bă Tiêm): b. 1958. Residence: Tuoh Klah Hamlet, Glar Commune, Dak Doa District, Gia Lai Province. He joined other Christians in protesting against the local government's suppression of religious freedom. He also joined a Montagnard association based in the U.S. He was arrested on 12/22/2008, sentenced to 10 years in prison, and detained in Prison #5, Town of Thong Nhat, Yen Dinh District, Thanh Hoa Province.
34. Mr. Noh, b. 1959, a member of a Montagnard association

based in the USA. For demanding religious and indigenous rights, he was sentenced on 9/4/2009 to 12 years in prison for "undermining the national unity policy" (article 87 of the Penal Code); currently detained in Gia Lai.
35. Mr. Nuh (Ba Num): b. 1959. Residence: Glar village, Dak Doa District, Gia Lai Province. In 2001, he joined the other Ba Na members of this church to protest the government's disregard for religious freedom. In reprisal, the police beat the demonstrators brutally. A number of them were injured or even died, and many were arrested. His religious activities resulted in his arrest in 2004. He was sentenced to 12 years in prison. He is currently in Prison #3, Phu Xuan 4, Co Lung Commune, Phu Luong District, Thai Nguyen Province.
36. Mr. Rah Lan Blom, b. 1976 of Jrai ethnicity. For demanding religious and indigenous rights, he was sentenced on 04/05/2011 to 9 years in prison and 3 years of house arrest for "undermining the national unity policy" (article 87 of the Penal Code); detained in Gia Lai.
37. Mr. Rah Lan Mlih, b. 1966 of Jrai ethnicity. For demanding religious and indigenous rights, he was sentenced on 04/05/2011 to 9 years in prison and 3 years of house arrest for "undermining the national unity policy" (article 87 of the Penal Code); detained in Gia Lai.
38. Mr. Rmah Hlach, b. 1968 of Jrai ethnicity. For demanding religious and indigenous rights, he was sentenced on 01/14/2010 to 12 years in prison and 3 years of house arrest for "undermining the national unity policy" (article 87 of the Penal Code); detained in Gia Lai.
39. Mrs. Rmah Hruth, a Jrai woman. Residence: Nang Hra Village, la Hla Commune, Cu Puh District, Gia lai Province. She was arrested in March 2014 and sentenced 5 years in iprison. Rmah H Ruth is a religious activist in Gia lai who conducted religious activities for her fellow Montagnard Christians. She is currently imprisoned in T20 - Gia Trung Prison, Gia Lai Province.
40. Mr. Rmah Hueh, b. 1960 of Jrai ethnicity. Residence: Plei Ksing Village, Ea Pa Commune, Phu Thien District, Gia Lai Province. In 2002 Rmah Hueh participated in protests, demanding religious freedom. Facing imminent arrest, he escaped to Cambodia seeking for asylum from UNHCR. On September 9, 2004 he was arrested by Vietnamese agents in Cambodia and brought back to Vietnam. He continues to be detained in prison after 13 years; it is unclear whether he was tried and sentenced.
 41. Mr. Rmah Klum: b. 1964. Residence: Lop Village, Ya Le Commune, Chu Puh District, Gia Lai Province. A member of the Evangelical Church of Vietnam (Southern Region), he worshipped at home. Police arrested him at his home in October 2016, detained him for 19 days, and tortured him for his religious activities. 42. Mr. Rmah Pro: b. 1964. Residence: La Kbel Hamlet, Duc Co

District, Gia Lai Province. He participated in a demonstration demanding religious freedom in 2004. He had been advocating for religious freedom until he was arrested and charged with undermining national solidarity in 2009. He is currently serving his sentence in Phu Son 4 Prison, National Security Section, Section 3, Co Lung Village, Phu Luong District, Thai Nguyen Province 43. Mr. Runh: b. 1979. Residence: Kret Krot Hamlet, Hra Commune, Mang Yang District, Gia Lai Province. An influential pastor among the Ba Na ethnic community associated with the Kret Krot Evangelical Church, he had been defending his Church's right to freedom of religion. He
was requested to go to the local police station for interrogation. There, his interrogators beat him and issued an order forbidding him to engage in religious activities. Arrested on 04/23/2012, he was sentenced to 10 years in prison, followed by a 3-year probationary period. He is currently in Prison #5, Town of Thong Nhat, Yen Dinh District, Thanh Hoa Province.
44. Mr. Ro Lan Ju (Ama Suit) of Jrai ethnicity. For demanding religious and indigenous rights, he was sentenced on 07/21/2009 to 9 years in prison for "undermining the national unity policy" (article 87 of the Penal Code); detained in Gia Lai.
45. Mr. Ro Mah Klit, b. 1946 of Jrai ethnicity. For demanding religious and indigenous rights, he was sentenced on 04/05/2011 to 8 years in prison and 3 years of house arrest for "undermining the national unity policy" (article 87 of the Penal Code); detained in Gia Lai.
46. Mr. Rmah Pôl, b. 1953 of Jrai ethnicity. For demanding religious and indigenous rights, he was sentenced on 03/27/2009 to 7 years in prison and 3 years of house arrest for "undermining the national unity policy" (article 87 of the Penal Code); detained in Gia Lai.
47. Mr. Siu Ben (Ama Yon) of Jrai ethnicity. For demanding religious and indigenous rights, he was sentenced on July 21, 2009 to 12 years in prison for "undermining the national unity policy" (article 87 of the Penal Code); detained in Gia Lai.
48. Mr. Siu Bler: b. 1962. Residence: Amoi Hamlet, Tapet Commune, Dak Doa District, Gia Lai Province. An influential pastor among the Ba Na ethnic community associated with the Amoi Evangelical Church, he had been defending his Church's right to freedom of religion. After years of government harassment, his community staged a protest in 2001. After the government cracked down, they sentenced him to 2 years in Gia Trung Prison in Gia Lai, followed by a 2-year probationary period. His subsequent opposition to government interference led to his arrest on 8-27-2004 and he was sentenced to 17 years in prison, followed by a 3-year probationary period. He was tortured brutally in prison until

half of his body became paralyzed. He is currently in Nam Ha Prison in Ha Nam Province.
49. Siu Brom, b. 1967 of Jrai ethnicity. For demanding religious and indigenous rights, he was sentenced on 04/05/2011 to 10 years in prison and 3 years of house arrest for "undermining the national unity policy" (article 87 of the Penal Code); detained in Gia Lai.
50. Mr. Siu Hlom, b. 1967 of Jrai ethnicity. For refusing to
renounce his Christian faith, he was sentenced on 04/05/2011 to 12 years in prison and 3 years of house arrest for "undermining the national unity policy" (article 87 of the Penal Code); detained in Gia Lai.
51. Siu Jă (Ama Hyen) of Jrai ethnicity. For demanding religious and indigenous rights, he was sentenced on 07/21/2009 to 7 years in prison for "undermining the national unity policy" (article 87 of the Penal Code); detained in Gia Lai.
52. Mr. Siu Koch, b. 1985 of Jrai ethnicity. For demanding
religious and indigenous rights, he was sentenced on 14/1/2010 to 9 years in prison and 3 years of house arrest for "undermining the national unity policy" (article 87 of the
Penal Code); detained in Gia Lai.
53. Mr. Siu Nheo: b. 1955. Residence: Plei Do Hamlet, Chu A Commune, Pleiku District, Gia Lai Province. An evangelical pastor within the Ba Na ethnic minority group, he and others participated in a demonstration demanding religious freedom in 2004. He had been advocating for religious freedom in the face of government suppression. He spoke out against the government's suppression in defense of the evangelists and their Church. As a result, he was arrested in 2009 and sentenced to 10 years in prison. Ever since his imprisonment, his wife and children have been victims of injustice and lack even basic necessities.
 54. Siu Thái, b. 1978 of Jrai ethnicity. For demanding religious and indigenous rights, he was sentenced on 12/19/2011 to 10 years in prison for "undermining the national unity policy" (article 87 of the Penal Code); detained in Gia Lai. 55. Mr. Siu Wiu: b. 1977. Residence: Plơi wai Hamlet, la Plar Commune, Phú Thuận District, Gia Lai Province. As a member of the Ba Na ethnic minority group, he had been advocating for religious freedom in the face of government suppression. As a result, he was arrested in 2009 and sentenced to 8 years in prison.
56. Mr. Thin: b. 1979. Residence: Kret Krot Hamlet, H'ra Commune, Mang Yang District, Gia Lai Province. On 04-26-16 he was sentenced along with 4 other Montagnard Christians to 6 years in prison followed with 3 years of house arrest for undermining national unity (Article 87). He is being held at Phu Yen Prison.

57. Y Adam Mlo is about 20 years old a EDE man in Buon ho, Dak lak province. He participated to protest demanding land grabbed return on 2002, he was arrested on 25 -12-2002. Adam Mlo sentenced 8 years imprison, in the prison the Police torture and beating him a lot, he dead in Ha nam prison.
58. Mr. Y Ben Nie: b. 1971. Residence: Tang 3 U Hamlet, Ea Kao District, Buon Me Thuot Province. An evangelical pastor, he was imprisoned for participating in a demonstration demanding religious freedom. He was arrested in 2004 and sentenced to 13 years in prison pursuant to Article 87, undermining national solidarity. He is currently serving his sentence in Phu Son 4 Prison, National Security Section, Division 3, Co Lung Village, Phu Luong District, Thai Nguyen Province.
59. Mr. Y Blao Kpor: b. 1964. Residence: Cour B Hamlet, Ea Ana District, Daklak Province. He was a member of Cour B Church's executive committee.
