Over 100 members of the independent Cao Dai Church were involved.

An Ninh Tay Cao Dai Temple in An Hoa Hamlet, An Ninh Tay Commune, Duc Hoa District, Long An Province, Vietnam.

All are Vietnamese citizens of the main "Kinh" ethnic group.

-Does domestic law require (re-) registration of religious associations and if yes, what is the current status of the group in question?

Vietnam requires all religious organizations to register. The state-sponsored Cao Dai organization seized the Central Temple and its original name belonging to the independent Cao Dai Church, and assumed this Church's identity. The state-sponsored Church has been attempting to take over the few temples remaining under the control of the independent Church, e.g. the one in An Ninh Tay.

At 1:50 pm on March 24, 2016, the government and state-sponsored Cao Dai Church mounted an operation to seize ANT Temple. Government officials involved included: Mr. Vo Van Bon, deputy chief of public security of ANT Commune; Mr. Nguyen Thanh Phong, Religious Affairs Committee of ANT Commune; Mr. Lai Tri Man, deputy chairman, Religious Affairs Committee, and member, Cultural and Information Committee of ANT Commune; Mr. Quy, Communist Party Secretary of An Hoa Branch; and a number of public security officers of ANT Commune.

Members of the state-sponsored Church included: (a) GS Thuong Canh Thanh, chairman of Committee Representing 36 religious units of the Town of Tan An, Long An Province; (b) Temple Manager Thuong Nhuong Thanh, manager of the temple in the Town of Hau Nghia, Duc Hoa District, Long An Province (the state-sponsored Church appointed Mr. Nhuong manager of ANT Temple, but he met with resistance from members of the independent Church and local residents; he had participated in previous operations intended to seize temples belonging to members of the independent Church); (c) Mr. Thuong Ngoan Thanh and a number of Le Sanh-rank members who manage temples in other locations. The group rushed into ANT Temple, bringing with them 2 locks to lock down the front and back doors (Photos 4, 5 in addendum).

The group went to see Sub-dignitary Le Minh Chau and Assistant Dignitary Phan Trong Huu to demand that they ceded the temple to them. Seeing the belligerent attitude of the intruders, the two men ran outside. Upon discovering that the intruders had locked the doors, the two men screamed for help. Local residents rushed over to help defend the property.

Approximately 10 minutes later, local residents broke through the gate to help Messrs. Chau and Huu, and additional residents came to support them. The intruders saw the growing size of the defenders' group and decided to leave. Public Security Deputy Chief Ban was the first person to run out.

Rather than letting the intruders take off, the defenders insisted that the illegal entry group explain their unethical and unlawful attempt (Video clip 1 in addendum).

With government representatives among the intruding group listening, the defenders stated that the temple resulted from the Ho Pháp's endeavors in the distant past, and their faith was with Sub-dignitary Chau who follows the authentic Cao Dai Church, and not with the state-sponsored Cao Dai Church. The defenders requested the governments of the commune, district, and Long An Province to cease interfering with their Church's internal affairs, and to warn state-sponsored Church members to refrain from coming to the temple to cause trouble.

At 5 p.m., Mr. Chau requested the local residents and other followers of the original Church to let the intruders leave. He also expressed his hope for the cessation of attempts to take over the temple (Video clip 2 in addendum).

-Which indications exist that the victim(s) has been targeted because of his/her religion or belief?

Government officials such as the commune's public security officers and members of the commune's Religious Affairs Committee, and members of the state-sponsored Cao Dai Church have been attempting to pressure the followers of the independent Cao Dai Church (founded in 1926) to join the state-sponsored Church that the government had established in 1997.

- In attacking a temple whose adherents have been holding out against the government's pressure, the government and its sponsored Church violated the original Church's property ownership and cultural rights.
- With respect to the Universal Declaration of Human Rights and international covenants: they also violated Article 18 of the Universal Declaration of Human Rights and Article 18 of the International Covenant on Civil and Political Rights (on freedom of thought, conscience, and religion).
- With respect to Vietnamese law:

They violated Articles 14 and 24 of the 2013 Constitution, Article 1 of the 2004 Ordinance #21 on belief and religion, and Article 2 of Decree #92 in the area of freedom of belief or religion. The government and its state-sponsored Church continue to implement the latter's Circular # 42/90 issued on October 14, 2015, essentially directing regional Church Governing committees to forcibly prevent adherents of the independent, vintage 1926 Church from practicing their faith and conducting religious activities (the government appended its appeal to local authorities to assist the state-sponsored Church in its violation).

-Identification of the alleged perpetrator(s), name(s) if known and/or function, suspected motive: Participating government officials included:

Mr. Vo Van Bon, deputy chief of public security of An Ninh Tay Commune; Mr. Nguyen Thanh Phong, a member of the commune's Religious Affairs Committee; Mr. Man, deputy chairman of the commune's Religious Affairs Committee; Mr. Quy, Communist Party Secretary of An Hoa Branch; and a number of the commune's public security officers.

Members of the state-sponsored Church included: GS Thuong Canh Thanh, chairman of Committee Representing 36 religious units of the Town of Tan An, Long An Province; Temple Manager Thuong Nhuong Thanh; Mr. Thuong Ngoan Thanh, and a number of Le Sanh-rank members who manage temples in other locations.

The intruders' motive is to continue the implementation of the central government's Cao Dai decision of July 20, 1978 and resolution of December 13, 1978 aiming at exterminating the Cao Dai Church and its doctrine.

Are the perpetrator(s) known to the victim? Yes (Video clip 2 in addendum)

Are State agents or non-State-actors believed to be responsible for the alleged violation?

The perpetrators are government employees and the state-sponsored Cao Dai Church is the government's instrument used to systematically eliminate the independent Church. The government must be held accountable for this violation of human rights.

-If the perpetrators are believed to be State agents, please specify (police, military, agents of security services, unit to which they belong, rank and functions, etc.), and indicate why they are believed to be responsible; be as precise as possible.

It is evident that the following perpetrators are state agents: Mr. Vo Van Bon, deputy chief of public security of An Ninh Tay Commune; Mr. Nguyen Thanh Phong, a member of the commune's Religious Affairs Committee; Mr. Man, deputy chairman of the commune's Religious Affairs Committee; Mr. Quy, Communist Party Secretary of An Hoa Branch; and a number of the commune's public security officers. They must be held accountable for violating domestic law and going against international conventions whose clauses they were supposed to implement.

The victims could identify the perpetrators as state agents, i.e., government employees and members of the state-sponsored Church.

The government does not and will not investigate because, as in numerous other cases, it is the mastermind and coordinator of the violations.

The government would accuse authors of complaints of plotting to overthrow the government. Depending on specific circumstances, public security would request targeted individuals to report for interrogations during working sessions, or would accumulate evidence so that the government can charge them with harming national security.

<u>Deputy chief of public security of ANT Commune, Mr. Vo Van Bon, ran away to hide his role in directing the</u> attack on the temple.

Thanks to the timely intervention by local residents and Church adherents, the government failed in its attempt to seize An Ninh Tây Temple. Mr. Vo Van Bon, deputy director of the commune's public security organization, was the first to run. However, the defenders had just locked the gate. Mr. Bon changed his position in an attempt to extricate himself and leave members of the state-sponsored Church behind. Second No. 45: ... *Unlock the gate first before we talk it over...* (whereas the intruders were the ones who had brought the locks in their plot to prevent intervention from the outside while they attempted to seize control of the temple).

Second 1,14: government official feigning innocence and having nothing to do with the attempt 1,49: The deputy director of the commune's public security organization directing the intruders asking for the current, authentic temple administrator, Mr. Le Minh Chau.

After the exit of the deputy director of the commune's public security organization, the gathered rescuers expressed their faith in Sub-dignitary Lê Minh Châu and unhappiness with the state-sponsored Church members.

- 1,35: Seeing state-sponsored Church members out while feeling outraged; insisting on keeping the locks as evidence.
- 3,09: Asking state-sponsored Church members to behave as good religious people once they leave.
- 3,35: Not letting go of state-sponsored Church members' vehicles and demanding keys ...resolutely.
- 4,57: Chiding state-sponsored Church members for entry with the objective of forcibly seizing the property Finally, peace has returned for the authentic adherents.

Circular No. 42/90

Committee representing The Church Tay NInh Province No. 42/90. BDD. VT Church of the Great Way of the Third Age of Universal Redemption (90th year) Tay Ninh Temple

To: Governing committees of 75 local church branches in Tay Ninh Province

The Committee representing the Tay Ninh Temple has received much input from believers and Governing committees of local church branches. In the recent past, a group in Tay Ninh Province proclaimed themselves as "Adherents of the Original, Authentic Church" and conducted rites such as funeral, Taking Position, Statue Installation, Healing Prayers, etc. in the local branches' communities at the homes of adherents who are less knowledgeable about our Church's laws and do not understand the principles, procedures, administrative prescription, and rites that the Church has promulgated.

By order of the Tay Ninh Temple and based on the meeting on Day 26 of the 8th lunar month in the Year of the Goat (October 8, 2015) involving the Committee and Governing committee representatives of the 75 local Church branches, during which there was uniform agreement on measures needed to prevent and reverse the violations carried out by the self-proclaimed "Adherents of the Original, Authentic Church". The measures include:

1/Members of Governing committees, clergy, adherents appointed to functions, and believers shall, upon finding out that those masquerading as Cao Dai adherents or representatives of Tay Ninh Temple are coming to your communities to conduct unauthorized religious operation or activities, should (this applies to Governing committee members and adherents appointed to functions) intervene and provide thorough explanations, and help them obey the Church's laws. Should the unauthorized group refuse to comply, you shall immediately notify in writing the local government so that it provides you with legal support and enforcement authority.

2/Mobilize and organize intervention by adherents appointed to functions, personnel from the Church's committees and departments with the intent to disperse and firmly deny the unauthorized group the opportunity to carry out its plans.

3/Notify the nearby branches' Governing committees and ask for additional personnel to provide support for upholding our Church's internal solidarity as guided by the Committee representing the Tay Ninh Temple. This is necessary for us to fulfill the mission that the Temple has assigned and uphold the Church's laws in accordance with the responsibility of clergy members and adherents appointed to functions.

4/Resolutely prevent the self-proclaimed "Adherents of the Original, Authentic Church" from organizing religious activities not authorized by the Church and with the potential to degrade the Cao Dai Church's authority and prestige.

We ardently desire that Governing committees, clergy, adherents appointed to functions, and believers work closely with one another to implement well the Church's teachings, maintain order, peace, love, and glory to our Church for this and future generations.
