Appendix 1 – Statelessness among Hmong Communities

(compiled by Pastor Wa Chi Minh Vang, Hmong United for Justice)

From 1998 on, the Communist government's persecution of Protestant Churches in Vietnam's Northwestern provinces - under the pretext that H'Mong Protestants are agents of the U.S. who support the U.S. in overthrowing the local government in the Northwest to establish a H'Mong kingdom. Members of the H'Mong communities had to flee to the Central Highlands where the local government discriminates against them and frequently subjects them to threats, violence, and suppression.

The Central Highlands authorities refuse to allow them to register as legal residents and refuse to issue personal papers such as ID cards and birth certificates. The victimized adults and their children receive no public benefits. Approximately 1,100 families in the Northwestern and Central Highlands provinces lack these basic papers.

I. Tally of households lacking basic ID and residency papers in the Northwestern and Central Highlands provinces.

1. Northwestern provinces

Appendix 2 – Doan Ket Village's stateless Hmong Christians

The Doan Ket Protestant community lies within Doan Ket Village in Dak Ngo Commune, Tuy Duc District, Dak Nong Province. Doan Ket is approximately 25 km from the seat of the district government and 100 km from the seat of the provincial government. The locals make a living mostly through growing cassava, cashews and coffee, and therefore their livelihood is not very stable. The residents' education level is not high and the local economy is not so good.

Doan Ket Village - population 1300 - consists of approximately 300 households. Of these 127 are with household registration cards (proof of residency) and other papers such as ID cards. The remaining households, comprised of some 700 individuals, are targeted by the local government for their religious belief and have been denied household registration cards and other papers. Without proper documents, they cannot own land use right (for residential and crop land) and homes, married couples are not issued marriage certificates and children are barred from education. Among them, 22 couples cannot register for a marriage certificate.

Most adversely affected are the children. They suffer greatly because of their "statelessness" resulting from their families having no papers such as ID cards and household registration cards. Children whose parents are without marriage certificates were issued birth certificates without the father's name. This is out of compliance with UN Convention on the Right of the Child (CRC) Article 8.1: "States Parties undertake to respect the right of the child to preserve his or her identity, including nationality, name and family relations as recognized by law without unlawful interference".

Seven children cannot go to school because their parents do not have local residency status and marriage certificates. Forty children may go to school but do not get the public financial assistance commensurate with their poverty level because their families do not have the needed papers. Although their families are indeed the most disadvantaged ones in the village, they have to pay full tuition and pay for all school supplies. This has forced several children to stop going to school and, instead, finding menial work to help their families survive. Of the handful of children who are in 10th grade or higher, the local government does not allow them to take the national high school graduation exam (even if they manage to pay the costs associated with the 12th grade) because of their stateless status, thus denying them their high school diplomas. The treatment of children in Doan Ket Village is out of compliance with Article 28 of the CRC: States Parties recognize the right of the child to education.

Most H'Mong Christians moved here from Northern Vietnam to be able to practice their Christian faith, but also as a result of extreme poverty. The economic driver motivated many other H'Mongs who are not Christian to move South to the Central Highlands. While the local authorities in the Christians' new community have not aggressively persecuted them for their faith, they chose not to give priority to these internal refugees' statelessness, i.e., not accelerating the process for giving them the all-important household registration that denotes legal residency without which they cannot apply for essential papers such as marriage certificates, death certificates, social benefits, or permits to use land for building their homes or to use cropland to make a living. While it is true that the government had a policy aimed to resettle Northerners in the Central Highlands in the past and the Central Highlands local

government units did strive to accommodate the planned influx, the large number of migrants who came on their own {"unconstrained migrants") over the past 15 years has led to the current situation for many Christians and non-Christians.

Nearly 170 households (approximately 700 individuals) are homeless and live in makeshift shacks. Households from Northern Vietnam typically involve couples whose marriage certificates were issued by their local government in Northern Vietnam. 22 couples who got married after moving from Northern Vietnam cannot apply for marriage certificates because statelessness has not allowed the groom and bride to get permanent residency (household registration) in their current location. For most couples, children born in Northern Vietnam have birth certificates (issued in Northern Vietnam where the parents were legally married) but children born in Doan Ket Village (after the family moved from Northern Vietnam) are not allowed to get birth certificates because their current local government treats them as stateless and the couple has no legal residency (through household registration). Those who have no land to farm - because the local government does not allocate land to those considered to be non-residents - must work for others for very low wages.

Vietnamese law prohibits children without birth certificates (they are primarily from unregistered households) from enrolling in public schools (a few exceptions were made at the school staff's discretion, subject to revocation). Those with birth certificates but without household registration may complete elementary school and middle school but may not enroll in high school. None of the children attending school receives financial aid for tuition, school supplies, and student health insurance because their households have no legal residency although they are the most disadvantaged ones in the community.

A number of listed children are not yet school age but will face the same difficulties as current schoolage children when they reach school age (may not receive aid for needy students, future enrollment at the discretion of school staff, and frequently not allowed to receive a high school diploma even after completing all the requirements, etc. in view of their statelessness (no household registration and/or no birth certificate).

About 50 children are affected by lack of household registration. Nearly 10 children born in 2010-2012 have had no schooling at all; more than 40 older children who want to continue in school could not do so. The 40+ children are among those with birth certificates (issued by the local government in Northern Vietnam before the families moved to their current location) but whose households are not registered in their current community.

Details are shown in the table below.

Appendix 4 – Vu Bon Commune's stateless of Hmong Christians

Stateless H'Mong Christians in Vu Bon Commune, Krong Pak District, Daklak Province, Vietnam (Adherents of the Evangelical Church Of Vietnam (VN)/Southern Region)

166 households (approximately 930 individuals) are homeless and live in makeshift shacks. Households from Northern Vietnam typically involve couples whose marriage certificates were issued by their local government in Northern Vietnam. 33 couples who got married after moving from Northern Vietnam cannot apply for marriage certificates because statelessness has not allowed the groom and bride to get permanent residency (household registration) in their current location. For most couples, children born in Northern Vietnam have birth certificates (issued in Northern Vietnam where the parents were legally married) but children born in Vu Bon Commune (after the family moved from Northern Vietnam) are not allowed to get birth certificates because their current local government treats them as stateless and the couple has no legal residency (through household registration). Those who have no land to farm - because the local government does not allocate land to those considered to be non-residents - must work for others for very low wages.

Vietnamese law prohibits children without birth certificates (they are primarily from unregistered households) from enrolling in public schools (a few exceptions were made at the school staff's discretion, subject to revocation). Those with birth certificates but without household registration may complete elementary school and middle school but may not enroll in high school. None of the children attending school receives financial aid for tuition, school supplies, and student health insurance because their households have no legal residency although they are the most disadvantaged ones in the community.

A number of listed children are not yet school age but will face the same difficulties as current schoolage children when they reach school age (may not receive aid for needy students, future enrollment at the discretion of school staff, and frequently not allowed to receive a high school diploma even after completing all the requirements, etc. in view of their statelessness (no household registration and/or no birth certificate).

About 70 children are affected by lack of household registration. 14 children born in 2010-2012 have had no schooling at all; more than 50 older children who want to continue in school could not do so. The 50+ children are among those with birth certificates (issued by the local government in Northern Vietnam before the families moved to their current location) but whose households are not registered in their current community.

Appendix 2 – Xa Que Village: from stateless to "religionless"

1. History

Xà Quế Village (established in 2008) is in Chung Chải Commune, Mường Nhé District, Điện Biên Province, about 8 km from the seat of the commune, 40 km from the seat of the district, and 300 km from the Town of Điện Biên. Its population is 95 households (a little more than 600 residents). Điện Biên Province was a part of Lai Châu Province before the central government split it away from Lai Châu Province in 2006 [1]

The Communist government view Hmongs who adopted Protestantism as collaborating with the U.S. in its effort to establish an independent Hmong kingdom. Beginning in 1992, Lai Châu Security Branch police and border guards were instructed to stamp out Christianity among the Hmong population through coercing non-Christians to denounce Christians, and detention, imprisonment, monetary fines, property confiscation, torture including beating and exposure to the hot sun, etc. until victims signed pledges to renounce their religious faith phơi nắng. Victims who wanted to remain Christian had no other choice than relocating to distant communities or moving deep into the forest.

The Xà Quế Community was one of the most isolated and remote settlements in the region, a potential refuge from persecution. Very soon after the establishment of Điện Biên Province in 2006, 50 households moved to the Xà Quế Community from Sình Hồ District (in Lai Châu) and 39 households moved there from Mường Chà District (in Điện Biên Province). 7 households moved to the community in 2010-2015 from Điện Biên Đông District (in Điện Biên). Up to 2017 Protestants in Xà Quế worshipped as 3 groups, 1 associated with the Inter-Evangelistic Movement Church (IEM) and the other 2 with the Evangelical Church of Vietnam/Northern Region, a member of the Christian and Missionary Alliance denomination (CMA).

In the past 3 years, the local police and border guards have been increasingly active in persecuting Xà Quế Protestants. For example, soldiers from a newly established border guards post in Xà Quế regularly arrest and fine (equivalent of US\$13-22 per victim) visitors from other localities, even if they just pay a visit to their local Christian friends or relatives (no intent to worship with them). This fine also applies to Protestant residents who need to go somewhere outside the village and serves to strictly control the movement of Xà Quế Protestants through requiring them to seek approval before they walk out of the village, regardless of the purpose of such trips.

2. Current adverse conditions

When the first HMong Protestants moved there in 2006, the government already started to persecute them through beatings and other forms of torture, destroying their living accommodations and other belongings, or seizing their possessions. For example, they beat up Cứ Sìa Chá, Cháng Giảng Hồ, and Thào Dũng Pó's wife (she had just given birth two days earlier), and took all their food reserves. Nevertheless, victims of relentless religious persecution in other localities continued to seek refuge here out of desperation.

After the community gained its village status in 2008, the local government issued household cards to 45 Xà Quế households, withholding them from dozens of Christian families. The local

government units within Mường Nhé used their administrative processes as a weapon for religious persecution in addition to urging residents to denounce those who converted to Christianity, forcing adherents to sign pledges to recant their faith, banning the use of cropland that adherents had let fallow for 2 years or more, controlling travel between villages (as previously described).

In 2010, Security Branch police units ramped up their persecution in Điện Biên Đông District (in Điện Biên Province) through convening non-Christian residents and leading them in operations against Christians (assault, confiscation of possessions, and expulsion from the community). Victims who were made homeless moved to Xà Quế in the 2010-2017 period. However, security police officers and border guards of the provincial and district police organizations pursued their victims all the way to Xà Quế Village to persecute them, i.e., harassing, assaulting, and expelling a number of those who do not recant their faith. In 2018, the police and border guards prevented adherents of the Inter-Evangelistic Movement Church from using their recently built prayer house. 14 households had to leave their Church and join the government-approved Evangelical Church of Vietnam/Northern Region to be allowed to conduct religious activities. 9 households remained with IEM in spite of the government's ban.

The addendum contains specific examples of local persecution.

3. Recommendations

The government should immediately:

- (1) Stop persecuting residents for religious reasons, both in this particular community and nationally
- (2) Rescind all restrictions on Christians using their cropland because this is their main source of subsistence.

ADDENDUM- Examples of Local Religious Persecution

<u>Pastor Hạng A Xá, originally from Điện Biên Đông District</u>

The government of his commune and Điện Biên Đông District Police staged 4 persecution operations involving numerous participants who used violence to force him to recant his faith and, because he did not yield, they ordered him to leave the village. He refused. After the third persecution operation, security police officers forcibly took him outside of the village while threatening to kill him if he returned. This 4th operation led him to hide in the forest during 35 days before escaping to Xà Quế.

In early 2017, Pastor Xá's daughter Hạng Thị Sua, a senior at the high school of Mường Nhé District, was told by the assistant principal that she was barred from taking the graduation examination because her family lacks a household registration card and she does not have a government issued ID card. The pastor went to see Senior Lt. Colonel Sùng A Lềnh, Deputy

Commander of the Security Branch of Mường Nhé District Police, and request that he issues a household registration card to the family so that the girl can be issued an ID card. Officer Lềnh requested the pastor to submit a written request which lists all the events that the family had gone through in their former community before moving to Xà Quế. The pastor did as requested and listed the persecution they had suffered in Điện Biên Đông District. Using this information, Mường Nhé District Police charged Pastor Xá with libel against the Communist State and diminishing the prestige of the Security Branch of the police. [2]

Phàng A Giàng and Lầu A Dàn, originally from Điện Biên Đông District

After the households of Phàng A Giàng and Lầu A Dàn adopted Protestantism in early 2015 in Nong U Commune, Điện Biên Đông District, the commune government and security police of the district persecuted them and expelled them from their commune. The victims moved to Xà Quế. In mid 2015, the security police of the police department of Điện Biên Province, the governments, border guards and security police of Điện Biên Đông District and Mường Nhé District came to Xà Quế to pursue the victims. When the other Protestants in Xà Quế, stood up for the victims, Mr. Thào A Tủa, Deputy Commander of the police division of Điện Biên Đông District, ordered Police Officer Mùa A Chía to drive a police vehicle towards the group, severely injuring 12 women and children (one of the victims still suffer from brain damage).

Escape to Thailand and Burma

Persecution in Vietnam forced the households of Hạng A Xá, Phàng A Giàng và Lầu A Dàn to seek asylum with UNHCR in Thailand. 5 other Xà Quế households and the household of Mr. Lầu A Thào, Xà Quế Village Chief had to escape to Burma. [3]

The remaining Christian households declared that they would also seek asylum in other countries if persecution continued in Mường Nhé District. [4] Only then did Điện Biên Province Police come to the village to issue household registration cards. The police did not list the households' religion, a required entry on the cards, but instead listed them as "No religion". When the households objected, the police replied that the province had not yet approve their Protestantism.
