Ms. Y Manh – illegally taken out of SAKAN Center Case Summary compiled by BPSOS-CAMSA, September 29, 2021

<u>Current location:</u> Reportedly at the private residence of Mr. Nguyễn Quốc Khánh, Vietnamese embassy's Second Secretary for migrant workers management.

Ms. Y Manh, a Montagnard woman in Kontum Province, signed the employment contract on March 31, 2017 and was sent to Saudi Arabia by Thăng Long OSC labor export company. After 10 months working without pay, she called the company's representative in Saudi Arabia, Ms. Phạm Thị Mây, for help. Ms. Mây is the representative of Thang Long OSC, a labor export company in Vietnam and also of a Saudi human resource company in Riyadh. She took the case to the Saudi police. The police tried to contact the employer to no avail. After seven more months of fruitless attempts, Ms. Mây arranged for Y Manh to leave the employer and stay at the SAKAN Center, a private entity partnering with the government of the Kingdom of Saudi Arabia to provide accommodation facilities for distressed migrant workers.

On November 9, 2020, Mr. Nguyễn Quốc Khánh, Vietnamese embassy's Second Secretary for migrant workers management, used the authority of the embassy to take Ms. Y Manh out of the SAKAN Center despite her objection and without notifying Thăng Long OSC. He also took two other Vietnamese women out of SAKAN Center along with Y Manh.

Mr. Khánh placed Ms. Y Manh with Ms. Thái Hà. Fearing for her personal safety, Ms. Y Manh called Ms. Mây for help. The latter contacted the shelter's management and learned that there was a request from the Vietnamese embassy for Ms. Y Manh to leave the center and that Mr. Nguyễn Quốc Khánh was the one picking her up. One of Y Manh's calls for help when she was

Ms. Mây contacted Mr. Khánh and insisted that he, now Ms. Y Manh's de facto custodian, must secure the 17 months of backpay for her. Unable to place Ms. Y Manh with another employer without the prior consent of both the migrant worker and Thăng Long OSC, on March 5, 2021, he transferred Y Manh from Ms. Thái Hà's home to his residence. Text message of Ms. Y Manh on August 1, 2021:

Dạ em ra vào ngày 9 tháng 11 ở nhà chị thái hà



Ngày 5 tháng 3 thì em ở nhà anh Khánh

"I left the center on November 9 and stayed at Ms. Thái Hà's. On March 5, I stayed at Mr. Khánh's."

At Mr. Khánh's home, Ms. Y Manh does house chores, including taking care of his newborn, to this day. Mr. Khánh pays her 1,500 Rials a month, turning her into an illegal and reluctant worker. On September 8, in a text message to Ms. Mây, she confirmed that she was still working at Mr. Khanh's house and reiterated her desire to go home. Mr. Khánh did not include her in the repatriation list that he compiled for the September 3, 2021 flight home. It is unclear what Mr. Khánh has done to get the employer to pay her for the 17 months of work.

On September 30, Mr. Khánh took Y Manh to SAKAN Center. He did not include her for repatriation on October 13. Meantime, around the same time, the police of Kon Tum took Mr. A Ngoai, a Montagnard, in for questioning after he visited Y Manh's parents in Vietnam and provided them with the draft complaint against Mr. Khánh and Thái Hà and request for the prompt repatriation of Y Manh. The police asked him for information of the legal expert who helped with the draft and promised to conduct further investigation. The police confiscated two mobile phones from A Ngoai.



Ms. Thái Thị Hà (aka Thái Hà):



She came to Saudi Arabia under Vietnam's labor export program and stayed illegally after the end of her contract. Later, she married a Vietnamese migrant worker by the name Ninh Phan. Although Saudi law would not permit the marriage of an illegal migrant, the Vietnamese embassy somehow made that possible.

Ms. Thái Hà frequently organizes parties at her home or at rented places to attract Vietnamese workers. She then enticed them to leave their employers to work illegally at other places.
