

## Pledge submitted by Viet Nam to the Human Rights 75 Secretariat December 2023

Original language of submission: English Type of pledge: Single (by one state/actor) Pledging entity: Viet Nam

Viet Nam commits to advancing the UDHR by more efforts and actions for better enjoyment of all human rights and fundamental freedoms for all in the country, leaving no one behind, including, among other priorities:

**PLEDGE NUMBER 1**: Strengthening the rule-of-law State with continued legal reforms to enhance the institutional, judicial and policy foundation related to human rights, and further incorporating provisions of international human rights treaties into national laws.

Expected deadline within which pledge will be realised: Dec 31, 2099

**PLEDGE NUMBER 2:** Fostering effective measures and allocating sufficient resources to better ensure all economic, social, cultural, civil and political rights.

Expected deadline within which pledge will be realised: Dec 31, 2099

**PLEDGE NUMBER 3:** Engaging responsibly in the work of the HRC and promoting the role and efficiency of the Council, with particular attention to the rights of vulnerable groups and the impacts of climate change on the enjoyment of human rights.

Expected deadline within which pledge will be realised: Dec 31, 2099

**PLEDGE NUMBER 4**: Accelerating the implementation of the Agenda 2030 for Sustainable Development, with priority given to reducing multidimensional poverty, minimizing inequality, safeguarding the sustainable livelihood for the people, improving the living condition and access to public services, and enhancing social security and social resilience in response to natural disasters and diseases, especially for vulnerable groups.

Expected deadline within which pledge will be realised: Dec 31, 2099

**PLEDGE NUMBER 5:** Strengthening education on human rights to raise public awareness and the capability of law enforcement agencies, including through full implementation of the National Scheme to incorporate human rights into the national education system.

**PLEDGE NUMBER 6:** Enhancing substantive dialogue and cooperation with all countries and UN mechanisms on human rights.

**PLEDGE NUMBER 7:** Further contributing to the promotion of dialogue, cooperation, tolerance, and mutual understanding among countries and stakeholders based on respect for independence, sovereignty, equality, and mutual benefits.

**PLEDGE NUMBER 8:** Making further substantive contributions to ASEAN human rights cooperation, particularly in the work of AICHR and the implementation of the ASEAN Human Rights Declaration.
