A group.

15 members of the independent Cao Dai Church were involved.

- -Countr(ies) in which the incident took place: Vietnam
  - -Nationality(ies) of the victim(s): All are Vietnamese citizens (Kinh ethnicity)
- -Does domestic law require (re-) registration of religious associations and if yes, what is the current status of the group in question?

Vietnam requires all religious organizations to register. In Vietnam, the government banned the authentic Cao Dai Church (established in 1926). The state-sponsored Cao Dai denomination (established in 1997) is a tool of the Communist regime for demolishing the independent, authentic Church. The Nam Hoài Nhơn Temple belongs to the independent Cao Dai Church. The government frequently collaborates with its sponsored Church in attempting to seize this temple.

Nam Hoài Nhơn Temple at: Hoài Tân Commune, Hoài Nhơn District, Bình Định Province Please provide a detailed description of the circumstances of the incident in which the alleged violation occurred and the nature of the government action:

**7/22/2017 (afternoon)**: 8 employees of the commune government and district government came to the temple to give a few soda bottles to Mrs. Phan Hương Đành, the Elder of the congregation (their agenda was to assess the situation in preparation for the government's taking over the temple).

**7/23/2017 8 a.m.**: on this first day of the lunar month, as the temple staff was preparing to conduct customary rites, government representatives and members of the government-sponsored Church entered the temple. The group included:

Võ xuân Phong, deputy chairperson of Hoài Tân Commune,

Ngô Tư, chairperson of the commune's Fatherland Front, and

A number of plainclothes policemen from the commune police force, and,

**Nguyễn Hợp** (religious name: Thái Hợp Thanh), lead representative of Bình Định Province's government-sponsored Church,

**Hồ tấn Thu** (religious name: Thượng thu Thanh), deputy lead representative of Bình Định Province's government-sponsored Church, and

Võ văn Đồng, government-sponsored Church member.

They approached the altar and began to read aloud their order to expel Mrs. Phan Hương Đành [religious name] (legal name: Phan Thị Đành), the Elder of Nam Hoài Nhơn Temple's congregation. The

initial government group included 6 additional employees of the Hoài Nhơn District government, but these officials left upon seeing the strong resistance by the Temple's adherents.

After trying for 3 hours to pressure the Nam Hoài Nhơn congregation, the government and government-sponsored groups withdrew.

**7/25/2017**: 3 government-sponsored Church members,

### Messrs. Tín, Hải and Thêu,

along with a number of plainclothes policemen entered the temple. They claimed that they were looking for 2 electric drills that they had left in the temple's religious objects storage cabinet (an authentic Church's adherent, Mr. Lương, is in charge of the cabinet). The made-up story was the government's pretext to try and seize the cabinet although the authentic Church owns it. There is no reason why the 2 drills would have been stored in the cabinet: this was Mr. Lương and the other authentic adherents' rebuttal. The government's party left.

-Which indications exist that the victim(s) has been targeted because of his/her religion or belief? In various districts in Vietnam, government officials such as police officers, members of the Religious Affairs Committee, and members of the state-sponsored Cao Dai denomination have been attempting to pressure the followers of the independent Cao Dai Church (founded in 1926) to join the state-sponsored denomination that the government established in 1997.

Are the perpetrator(s) known to the victim? Yes

Are State agents or non-State-actors believed to be responsible for the alleged violation?

The perpetrators are government employees and members of the government's Cao Dai denomination. -If the perpetrators are believed to be State agents, please specify (police, military, agents of security services, unit to which they belong, rank and functions, etc.), and indicate why they are believed to be responsible; be as precise as possible.

It is evident that the perpetrators are state agents (see their names and affiliations in a previous section) If identification as State agents is not possible, do you believe that government authorities or persons linked to them, are responsible for the incident? Why?

The victims could identify the perpetrators as state agents, i.e., Vietnamese government employees and members of the state-controlled Cao Dai denomination.
