Dear Mr. Chairman:

This is to request that the Committee authorize a delegation to visit refugee camps in Thailand and Hong Kong. As you know, these camps currently hold thousands of Vietnamese boat people and members of the Hmong ethnic minority from Laos. They are scheduled for repatriation at the conclusion later this year of the Comprehensive Plan of Action (C.P.A.) and serious questions have been raised about the appropriateness of such repatriation. A fact-finding visit by a Committee delegation would be most helpful to me and to other members of the Subcommittee on International Operations and Human Rights in its oversight and legislative functions with respect to refugee programs.

It is currently anticipated that the delegation will consist of Committee staff members, including Paul Berkowitz of the full Committee staff as well as Grover Joseph Rees, the Staff Director and Chief Counsel of our Subcommittee. We have also extended an invitation to Democratic staff members through Robert King, the Minority Staff Director on the Subcommittee. With your concurrence, I would also like to extend an invitation to all Members of the Committee who might wish to participate in the delegation.

The delegation would leave on April 8 and return on April 15. I am enclosing a tentative itinerary.

Thanks so much for your consideration of this request.
